2- Purpose and Basis of Personal Data Processing

• Informing our Customers about products improved and newly developed by Tekkart in order to create and/or increase customer satisfaction, campaigns, promotions, discounts, offers, events, sweepstakes, contests and opportunity activities and our services,

- Providing collective electronic message management to customers,
- Performing the basic functions necessary for Tekkart's website to work,
- Analyzing Tekkart's website and thus increasing its performance,
- Increasing the functionality of Tekkart's website and providing ease of use,
- Performing personalization, targeting and advertising activities for Tekkart's website,

• To communicate with our customers about the conditions, current status and updates of the contracts we have concluded under the relevant articles of the Law on Distance Sales Contract and Consumer Protection, to provide the necessary information, to fulfill the obligations undertaken in accordance with the contracts we have concluded,

• To be necessary to process the personal data of the parties to the contract, provided that it is directly related to the establishment or performance of the contract to be established with the customer,

• Being obligatory for Tekkart to fulfill its legal obligation,

• Organizing records and documents, providing information to public officials upon request and in accordance with the legislation,

• Providing a better shopping experience to Tekkart Customers, informing Customers about Tekkart products that might be of interest to Customers, "taking into account the interests of our customers", conveying current campaigns, offering suggestions to Customers, informing our customers about our services,

• To be able to use it in various marketing and advertising activities, and within this scope, to organize surveys in electronic and/or physical environment through contracted institutions,

• Performing the basic functions necessary for the operation of the Site, analyzing the Site and increasing the performance, functionality and ease of use of the Site,

• Tekkart can fulfill its legal obligations in accordance with the law and related legislation and use its rights arising from the current legislation,

3- To whom and for what purpose the Processed Personal Data can be transferred:

• Providing telecommunications products and/or services, e-commerce services (including trading platforms and online auctions), payment services,

- Providing retail sales and services,
- Realization of finance, investment, insurance, banking and credit card transactions,
- Providing telecommunication products and services,
- Providing e-commerce services (including trading platforms and online auctions) can be transferred by Tekkart.

4- Method and Legal Reason for Personal Data Collection:

Your personal data is primarily subject to the personal data processing conditions and purposes specified in Articles 5 and 6 of the Law, It can be processed and shared by Tekkart in line with the legal reasons and purposes under the heading "Purpose and Basis for Processing Personal Data" of this policy and the "Purpose of Processing Personal Data" heading specified in Article 2 of the Customer Clarification Text.

Your personal data can be collected verbally, in writing or electronically through automated or nonautomated methods within the framework of Tekkart's commercial activities, through our website, social media channels, parties with which we have business relations and/or receive services as a complement to our activities, contracted organizations and other similar channels.

5- Your rights pursuant to Article 11 of the Personal Data Protection Law;

As personal data owners, in accordance with Article 11 of the Law titled "Rights of the related person";

- Learning whether your personal data is processed or not,
- If your personal data has been processed, requesting information about it,

• To learn the purpose of processing your personal data and whether they are used in accordance with the purpose,

• Knowing the third parties to whom your personal data is transferred, in the border of country or abroad,

• Requesting correction of your personal data in case of incomplete or incorrect processing and requesting notification of the transaction made within this scope to the third parties to whom your personal data has been transferred,

• Requesting the deletion or destruction of your personal data in the event that the reasons requiring its processing cease to exist even though it has been processed in accordance with the provisions of the law and other legislation, and requesting the notification of the transaction made within this scope to the third parties to whom your personal data has been transferred,

• Objecting to the emergence of a result against you by analyzing your processed data exclusively through automated systems,

• Requesting the compensation of the damage in case you suffer damage due to the unlawful processing of your personal data,

you have rights.

As personal data owners, if you send your requests regarding your rights via e-mail to the web address specified under the title of 'Identity of Data Controller' above, or by mail to the company address, duly and stating your identity information, Tekkart will be responsible for your request as soon as possible and in the

shortest time possible. Within thirty (30) days, your request will be finalized free of charge, but if the transaction requires an additional cost, the fee in the tariff determined by the Personal Data Protection Board will be charged.

6- Keeping Your Personal Data Accurate and Up-to-Date

Customers have accepted and declared that they know that the correctness and up-to-date preservation of the information they share on the website is important for them to exercise their rights over their personal data under the Law and for other relevant legislation, and that they will be entirely responsible for providing false information.

7- Security, preservation and destruction of your personal data

Tekkart has a very high sensitivity and awareness about personal data security and protection of personal privacy. As Tekkart, we take the necessary administrative and technical measures to protect personal data against unauthorized access or loss, misuse, disclosure, alteration or destruction, to keep your personal data confidential, to ensure confidentiality and to ensure security. When necessary, Tekkart immediately informs you and the Personal Data Protection Board in accordance with the Law and personal data protection legislation.

The personal data of our customers specified in this Personal Data Protection and Privacy Policy are processed by Tekkart by providing security in accordance with the Personal Data Protection Procedure and the Personal Data Retention and Disposal Policy, especially the Law and the personal data protection legislation.

Your personal data is retained for the period required for the processing purposes specified in this Personal Data Protection and Privacy Policy, and in any case, for the statutory limitation periods specified in the legal regulations. Tekkart deletes, destroys or anonymizes your personal data in line with the Personal Data Retention and Destruction Policy, if the aforementioned periods expire or your request is deemed appropriate.
